

WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

Prior to attending an event at Honey Hollow Farm, I agree to the following:

- I understand that I am freely choosing to conduct activities on a farm and such activities engaged while on the premises of Honey Hollow Farm may be hazardous due the nature of the activities and/or the location on a farm.
- I expressly and specifically assume the risk of injury or harm in these activities or presence on the farm.
- I (and my family, heirs, and personal representatives) willingly and knowingly release the Honey Hollow Farm and its officers, owners, employees and agents from any and all liability for any personal injury or damage to property relating to my participation.
- I (and my family, heirs, and personal representatives) agree to assume all of the risks and responsibilities of my participation.
- I understand that I am solely responsible for any hospital or other costs arising out of any personal injury or property damage relating to my participation on Honey Hollow Farm.
- I acknowledge the contagious nature of the Coronavirus/COVID-19. I further acknowledge that Layla Broumand Phillips, Honey Hollow Farm, Honey Hollow Farm LLC, and any affiliated individuals or entities (hereinafter "Honey Hollow") has put in place preventative measures to reduce the spread of the Coronavirus/COVID 19.
- I understand that the risk of becoming exposed to and/or infected by the Coronavirus/ COVID-19 may result from my participation and/or presence at Honey Hollow.
- I voluntarily seek services provided by Honey Hollow and acknowledge my risk of to exposure to the Coronavirus/COVID-19. I acknowledge that I must comply with all set procedures to reduce the spread while attending classes at Honey Hollow Farm.

Honor & Mindfulness

While you have entrusted us with your best interest in mind, we are also placing our trust in you. We ask that each guest take responsibility for his/her own actions. We leave it up the discretion of each individual to proceed according to their comfort level. While we do not currently have any restrictions and we respect the choices of others, we only ask that individuals be mindful of the health and safety of others when making their choices. The choices we make affect the health and wellbeing of others, specifically other guests, staff and collaborators. We aim to honor and protect all who come to Honey Hollow Farm.

I attest that, by attending class myself:

- I am not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- I do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- I or any member of my household, has not experienced any symptoms of COVID-19, or has within the last week.
- I acknowledge and fully assume the risk of illness or death related to COVID-19 arising from my being on the premises and participating in the Activities and hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE (on behalf of myself and any minor children for whom I have the capacity contract) Honey Hollow from any liability related to COVID-19 which might occur as a result my being on the premises and participating in the Activities.
- This liability waiver and release extends to the farm together with all owners and participants in it. IN SIGNING THIS AGREEMENT, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Wavier of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Agreement for full, adequate and complete consideration fully intending to be bound by same.

I understand the following about the house/farm rules:

- When walking around the wooden floors, please be mindful of any marking shoes or shoes with large heels.
- Also, the staircases are old and steep and can be slippery. Please use caution on the stairs.
- **PLEASE DO NOT WALK ON STAIRS WITH SLIPPERY SOCKS.** Please walk with soft-sole shoes, grippy socks or barefoot.
- We do not typically allow pets. If you are considering bringing a pet, it will need to be pre-approved.
- Do remember that this is a working farm with a lot of equipment. For your safety, kindly stay out of the barns and the deer-fenced area.
- Honey Hollow Farm is a smoke-free facility.
- Any guests violating the smoking restrictions will be asked to leave the premises by the event staff.
- This is a drug free and non-smoking facility at all times, **NO EXCEPTIONS.**
- Client agrees, for everyone's safety, to ensure alcoholic beverages are consumed in a responsible manner. Honey Hollow Farm reserves the right, in its exclusive discretion, to expel anyone who in its judgment is intoxicated or under the influence of alcohol or drugs, or who shall in any

manner do or participate in any act jeopardizing the rights, use permit, or insurability of Honey Hollow Farm or the safety of its staff, guests, or building contents.
